On the occasion of the 25th anniversary of the Mercuriades Competition in 2005, the FCCQ and the Quebec government created the Entrepreneurial Promotion Award. It sought to honour the actions of individuals dedicated throughout their career to promoting entrepreneurial culture, particularly among young people.

In 2007, members of the selection committee chose to honour Mr. Yvon Gasse, Professor at the Faculté des sciences de l'administration de l'Université Laval and holder of the Chair for Entrepreneurship and Innovation, for his sustained efforts in the ideation and creation of measures aimed at encouraging entrepreneurship among young people.


